Homewood approves incentives for Burlington store on Halsted

Homewood trustees on April 12 approved an incentive package that would enable Burlington to develop a department store at 17825 Halsted Street. The space formerly was home to Office Max, which closed late in 2020.

The village agreed to rebate sales tax revenues collected from Burlington over a fouryear period, estimated to be approximately \$200,000, and gave support for a Cook County Class 8 property tax reduction.

To make the project viable, the board also agreed to support Class 8 designations for three adjacent properties: Smoothie King at 17715 Halsted; a vacant storefront at 17729 Halsted; and the storefront occupied by UChicago Medicine at 17805 Halsted.

The properties are owned by DIKA Homewood LLC.

Homewood Economic Development Director Angela Mesaros said all the properties qualify for Class 8 benefits.

Class 8 is a Cook County program intended to encourage development in areas plagued by economic stagnation. The designation is available to industrial or commercial developments in Bloom, Bremen, Calumet, Rich and Thornton townships.

With the designation a property is as-

sessed at 10% of market value for 10 years, 15% for the 11th year and 20% for the 12th year. It can be renewed in the 10th year or

The Homewood Appearance Commission voted down the company's request for a variance for a larger sign on the front facade of the Burlington store. The company said it needed greater visibility on Halsted

The board also voted to approve a Class 8 recommendation for the Chik-fil-A restaurant at 17450 Halsted Street, but not without dissent.

When the site at 175th and Halsted Streets was redeveloped, GMX Real Estate Group did not request a Class 8 designation.

Trustee Jay Heiferman voted against the recommendation, citing his belief that the restaurant does not appear to need the tax reduction.

"If Chik-fil-A wanted to come in here and give a presentation about the hardship of being on the property, I would be glad to listen

Mayor Richard Hofeld countered Heiferman's point.

"I feel in the South Suburbs, Class 8 is the equalizer and this is something that should have been at the time that this was first brought into the village and it should be done now," he said.
